MSF Clubs – Information for Families

Medication





If your child requires medication to be administered during club hours, please ensure that you have completed a copy of our Medication Administration Consent Form (for each medication).

Medication should be delivered to our clubs in its original packaging, with a pharmacy label on it confirming who the medicine is for and the dose required - this should match the information provided on the Medication Administration Consent Form. We are not permitted to administer medication without this.

'Nut-Free' Clubs



All MSF clubs are 'nut-free' zones. This means that food or products containing nuts/nut traces are not permitted.

We have children and staff at our clubs with life-threatening allergies to nuts, so any banned items (nuts or products containing nuts) found at our clubs will be removed immediately. Please ensure that you check packed lunches, snacks etc. carefully before sending to our clubs. Thank you.

Support/Mobility Equipment



Does your child require a wheelchair, buggy, walking frame, walking harness or use of a sling during club hours?

If yes, please ensure that you send these items with your child when attending our clubs. Equipment should be the most recent one(s) allocated for your child, to meet their current needs, and must be presented in good condition/safe working order.

Should a child arrive without the necessary equipment, parents/carers will be asked to go and collect these.

Mobile Phones, iPads, Smart Watches



In line with our Safeguarding Policy, personal electronic devices such as mobile phones, iPads and smart watches are not permitted at our clubs. Parents/carers must ensure that such items remain in their vehicles/do not enter our club, when dropping off and collecting their child.

If a child arrives at a club with a mobile phone/iPad/smart watch, they will be required to hand this to the playleader on arrival and this will be returned to them at the end of the club.

We thank you for your continued co-operation and support.



Update re: Admissions Policy & Provision for 18yr olds

Our Trustee Board has announced a change to the Admissions Policy and provision for 18year olds at Malvern Special Families.

From 1st September 2024, we will provide support for children / young people until the end of the academic year in which they turn 18 years old.

For example, if a child turns 18yrs on 1st February 2025 they will be permitted to continue accessing our clubs until the end of that academic year - Summer Term 2025 (excludes summer clubs).
